



2019 Summer Musical Theater Intensive Scholarship Aid Request

The program cost for the Summer Musical Theater Intensive (SMTI) four-week program is **\$1,500**.

- If you are requesting a scholarship, you must complete this application.
- Acceptance decisions are not affected by the scholarship aid requests.
- SMTI requires all scholarship aid applicants to submit the first 2 pages of the parents' /guardians' most recent federal income tax return. **Requests for aid without the requested documentation will not be considered.**
- You may provide information about additional circumstances we should consider.
- Scholarship aid is based on need.
- **A completed application does not guarantee granting of assistance.** Funds are limited and must be spread among qualified applicants.

Scholarship Deadlines:

If you are accepted into the Summer Musical Theater Intensive program and need to apply for a scholarship, you have two weeks from the time you are accepted to submit a \$100 non-refundable deposit and your scholarship application.

- For Early-Action Auditions, the deadline is January 30.
- For Regular Auditions, the deadline is March 6.

We will announce our scholarship decisions by March 15.
